






#### Membership Overview

- Membership year runs January 1 December 31
- New members are prorated upon joining
- Renewal grace period ends on March 31
- Membership categories:
  - **EXECUTIVE** (\$330) members are typically senior management professionals in director-level and higher positions.
  - **REGULAR** (\$225) members generally hold mid-level or supervisory positions.
  - **ENTRY** (\$105) members occupy non-salaried (hourly) positions with no supervisory or direct budgetary responsibilities and less than two years' experience in any facet of the cable telecommunications industry. After two years at this level, Entry level members will be automatically upgraded to Regular level.
  - **STUDENT** (\$24 per year) members are full-time students currently earning 6 credit hours at graduate level or 12 credit hours at undergraduate level.

### Membership Chair Responsibilities

- Create annual membership plan (due February 9)
- Identify and communicate member needs
- Engage members and prospective members in chapter activities
- Build relationships with companies and organizations
- Protect member information



#### Transitional Member Program

- Nearly 80% of all jobs are found through a professional network and The WICT Network continues to provide involvement for individuals seeking employment.
- The WICT Network offers \$100 off **Executive** or **Regular** level member dues for members in transition.
- This does not apply for new members.

### Membership Chair Responsibilities

- Chapter membership goals
  - Membership year January 1 through December 31.
  - Goals are determined by looking at the previous year's growth and talking with chapter leadership.

Chapter Name	Actual Total	Goal	Percentage

Renew	375	400	94%
Total	477	500	95%

- Membership Dues
  - All member dues are processed at The WICT Network Global.
  - Chapter rebates: 15% of membership dues.








#### Member Renewals and Recruitment

  - Start early in the year
